Admission on local transfer for the year 2024-25 from Kendriya Vidyalayas in Hyderabad Region will be done as per Kendriya Vidyalaya Sangathan Admission Admission Guidelines 2024-25 and its amendments. The Principal of all Kendriya Vidyalayas are hereby directed to inform the parents about the local transfer for the year 2024-25 duly displaying on school's notice board and school website and announcing the same in the morning assembly. The schedule for admission on local transfer is annexed with this order which may be adhered to and complied with. However, while receiving the application forms, please note that
